



CIRCULAR NO. 8 DATED 24 DECEMBER 2017

RULES AND REGULATIONS REGARDING THE EVENTS AND ENTERTAINMENT ACTIVITIES carried out within Dubai World Trade Centre Authority Free Zone

This circular relates to the Dubai World Trade Centre Authority ("DWTCA") Free Zone Rules and Regulations dated 1 October 2015 issued pursuant to Law No. 9 of 2015.

With effect from the date of this circular and pursuant to Rule 4.6 of the DWTCA Free Zone Rules and Regulations, it is decided that the following will apply:

ARTICLE (1) REGULATIONS 20

"Tariffs" of the DWTCA Free Zone Rules and Regulations shall be amended to add a new appendix to read as "Appendix 2" as follows:

ARTICLE (2)

The fees set out in Article (1) above shall come into effect from the effective date and shall be applied to all events and entertainment activities carried out within the Free Zone.

ARTICLE (3) EFFECTIVE DATE

This circular is effective from 13 December 2017.

Terms defined in the DWTCA Free Zone Rules & Regulations shall have the same meaning in this circular.

Rule 19 of the Free Zone Rules and Regulations shall apply to this circular as if set out full herein.
